BOARD OF TRUSTEES

You've probably noticed the equipment, scaffolding, and other evidence of work being done on our FUSN building recently. If you've been keeping up on Laurel's emails, you may know what's going on, but I've been reminded that many of you may be curious and not know.

Thanks primarily to the long dedication and strategic management of our amazing Buildings and Grounds volunteer, Laurel Farnsworth, FUSN's building has made quite a physical come-back in the last 20 years or so, after many more years of benign neglect. Benign because although no one wanted to let the building deteriorate, for many years FUSN had neither the money nor a knowledgeable volunteer to shepherd the needed maintenance work. Instead, the Society had to focus on rebuilding our congregation after membership shrank precipitously following a particularly divisive conflict in the 1960s over BAC bonds. (If you're interested in knowing more about this history, you'll find a brief history on the FUSN website at http://fusn.org/content/social-change-and-division; and/or you can ask some of our esteemed elders, who weathered that conflict and stayed to help us rebuild.)

Since the early 1990s, the proceeds of two capital campaigns and Laurel's careful and strategic management of the annual B&G budget have funded major reroofing of the sanctuary, rebuilding the bell tower, restoring stained glass windows, building classrooms in the basement, replacing outdated HVAC (air conditioning!) and lighting systems, and many more projects.

We all know we had a challenging winter last year. Many folks suffered major damage to their homes; our FUSN home was not exempt, although our damage was not catastrophic. Nevertheless, the work that's currently underway, most visibly on the back side (office wing) of the building, is masonry repair and roof slate replacement necessitated primarily by the damage from last winter's snow accumulation. The cost of this work will run about \$144,000. We'll be in much better shape to face that kind of challenging winter again, should we have to. (Yes, I'm crossing my fingers, praying, etc. along with the rest of you!)

But the building repair, maintenance, and improvement projects are not limited to reactive ones; there are proactive ones as well, designed to further some of our most important spiritual and justice-related values. Although we have one handicapped-accessible entrance, the door

by the back parking lot, our building is far from friendly for those with mobility challenges. There are long-range plans for major improvements in mobility throughout our building, some of which will be in line for a next capital campaign. In the meantime, however, we have just contracted for the initial design work to make our front narthex entrance on Highland Street accessible to those in wheelchairs. The Board voted in September to fund this design work for roughly \$10,000. We look forward to this work and future planned projects as ways to make our building be as welcoming as our membership program aspires to be.

I have been so impressed, as a 2+ year Board of Trustees member, every time Laurel presents a new project for discussion and approval. Before a proposal comes before us, there has been careful thought and planning, both of the work itself and its financing. It is always evident that a balance has been sought among sometimes competing values: the need to address the most urgent needs first; the desire to do long-range planning for our building with our ideals and mission as the guiding principle; the need to use our financial resources wisely, balancing frugality with quality; and the need and desire to be patient and thoughtful with the process while actually getting something done!

You'll be pleased, as I am, to know that all the work being done this fall is being financed from currently budgeted Buildings and Grounds funds – i.e., from the Operating Budget for FY16 which you all approved at last June's Annual Meeting. Even a hefty fee spent last winter to clear snow from the flat roof over the kitchen, in order to keep the roof from collapsing under the weight of all that snow, came from reserve funds set aside annually as part of the B&G budget.

We are so fortunate and grateful to have a dedicated volunteer who is able and willing to manage this kind of large portfolio of essential congregational business. Please offer your appreciation to Laurel Farnsworth when you have a chance, and know that she and the Board and Operations Council are carefully and prudently managing your generous pledge dollars.
