
Feb. 8 - "Am I My Sister's Keeper" - Rev. Marta Flanagan

This past year we've shared our hopes and concerns and personal details of our lives. Most notably we've shared in the loss of our Assistant Minister. We are troubled by her departure. We are at ease with her absence. We felt liberated by her words. We were profoundly offended by them. Many of us experienced emotions somewhere in between. We couldn't ask someone to stay who felt it was time to go. There is an empty space within us all, no matter what we felt. Divided as we are, we've respectfully listened to each other's viewpoints.

In her commencement speech to the 2013 Concord Academy graduating class, U.U. Rev. Kim K. Crawford Harvie previewed what is now her book, "5 Things I Know" (I recommend this book highly). One of the things she says is: "Never let a serious crisis go to waste." For we learn more from our mistakes than when everything is smooth sailing. Another is: "Befriend regret". She says when we befriend regret, we get off the hamster wheel of what might have been, could have been, should have been.

The soul has no rainbow, if the eyes have no tears. What's done is done. So... Let's look forward to what can be. What we were...We are. What we had...We have. ADULT R.E.

The Criminal Justice Speaker on Feb. 10 will be the new Massachusetts Commissioner of Probate Services, Ed Dolan. On Feb. 24 our speaker will be Mike Rezendes, the Boston Globe reporter who exposed the troubling conditions for incarcerated mentally ill prisoners at Bridgewater State Hospital. We will meet at 7:00 p.m., in the Parish Hall. All are welcome.

SPECIAL COLLECTION

The special collection for Feb. 22 will be to benefit the Massachusetts chapter of the National Alliance on Mental Illness. NAMI Mass has worked with the Department of Mental Health and local police officers in the Criminal Justice Diversion Project to encourage partnerships between law enforcement, mental health providers, and other stakeholders to work on diversion from jail and toward treatment when the circumstances are right. The project worked to launch a new mental health curriculum for police recruits and veteran officers. An even more comprehensive 40 hour Crisis Intervention Team (CIT) training was developed to more intensively train state and local police, and to develop a program to put a social worker in the car with police. Most reasons for arrest (loitering, homelessness, substance abuse) are not reasons for jailing a person. Police really appreciate having a knowledgeable social worker on board who knows many treatment plans and can set up a referral that the person can agree to. Please remember to bring your checkbook and make the check out to NAMI MASS.

NAMI tip: if you are concerned about someone in the family with a mental health problem who seems to be worsening, meet with your local police ahead of time with your concerns, so they will be clued in about what to expect. Another solution: call your local mental health service (Riverside for Newton) for a wellness check. They also have emergency services with a crisis hotline. Call Nancy Stanton 781-642-7284 with questions.

MUSINGS

The worship theme for February is faith, and the FUSN musicians will reflect on it in different ways. On Feb. 8 the choir will sing the inspiring anthem "I Am Only One" – with music by the composer Adolphus Hailstork, who was the music director for many years at the Unitarian Church of Norfolk (VA), and words by the Unitarian clergyman Edward Everett Hale. Hale (April 3, 1822-June 10, 1909) was one of the most prominent American Unitarian ministers of the last half of the nineteenth century. He was also a popular journalist, editor, and author. His short story, "The Man Without A Country," is an American masterpiece. An active social and charitable reformer, he founded the Lend a Hand Society to help people needing financial assistance.

On Feb. 15 our musicians will sing a movement from the contemporary cantata *Sources* by UU composer Jason Shelton. He writes, "(All Lifted Hearts) is a meditation on the golden rule, a bit of wisdom that seems to have manifested itself in nearly every culture and religious tradition found on the planet. It is simple in structure, a refrain which the congregation/audience is invited to sing interspersed with a narrative of the golden rule, followed by a choral prayer for peace in many languages."

We are so fortunate to have Deborah Selig as our soprano soloist. Some of her upcoming solo engagements include performances of Handel's *Messiah* in March, Vaughan Williams' *Dona Nobis Pacem*, and Orff's *Carmina Burana* (www.deborahselig.com). On Feb. 22 at FUSN she will sing Aaron Copland's setting of the the Emily Dickinson poem "Why do they shut me out of Heaven?
